This is for information to all concerned that certificate verification concerning to selection to the post of Under-Graduate Teacher (for I-V) 2017 and Graduate Teacher (for VI-VIII) 2017 will be held on **11.09.2017** at the office of TRBT, Shiksha Bhavan, Office Lane, Agartala. The reporting time is from 11.30 A. M. to 2.30 P. M. Candidates who have applied for the said posts vide notification dated: 27.05.2017 is hereby instructed to attend the programme. During certificate verification certificate/mark-sheet of academic and professional qualification including other relevant certificates/document of the candidates will be verified. Candidates are instructed to bring the following in original and two sets of self attested photocopies during certificate verification:

- (1) Downloaded Acknowledgement Page concerning to the post applied for
- (2) Permanent Resident of Tripura Certificate (PRTC)
- (3) Admit card of matriculation/madhyamik examination as age proof
- (4) Caste certificate (if applicable)
- (5) PH certificate (if applicable)
- (6) Mark-sheets (all semesters/years) of academic qualification
- (7) Mark-sheets (all semesters/years) of professional (teacher training) qualification
- (8) Certificates of academic and professional qualification (if any)
- (9) Photo bearing identity card, like PAN, Voter ID, Passport, AADHAR etc (any one)
- (10) No-objection certificate from the concerned authority (for in-service candidate)
- (11) Certificate/ Proof of ESM (if applicable) and
- (12) T-TET Certificate.

**VERY IMPORTANT**

- ❖ The candidates who have participated in the selection process pursuant to the advertisements dated, 29.10.2002, 05.04.2006 and 23.09.2009 of Education (School) Department, Government of Tripura, whether selected or not, will have to produce either (i) Interview call letters issued against relevant advertisement or (ii) Copy of appointment letter (in the cases of in-service teachers who were appointed in reference to the relevant advertisement/ notification) or (iii) Copy of receipt of application for the post of school teachers against relevant advertisement for getting age relaxation as per verdict of the Honourable Supreme Court.
- ❖ Having one's certificate verified does not confer any right on any candidate for recruitment, since it depends on fulfilment of conditions of eligibility as well as number of sanctioned posts.
- ❖ If a candidate doesn't turn up during certificate verification as per schedule of TRBT or any discrepancy of fact is found during certificate verification; her/his candidature will be cancelled and no further communication will be entertained.
